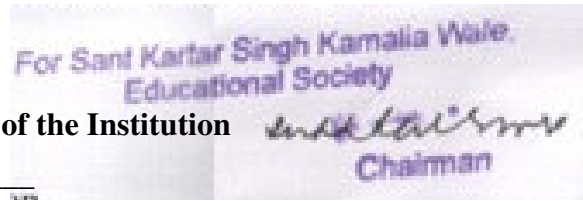

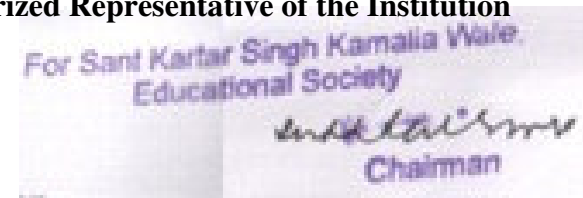
#### **CERTIFICATE FROM THE MANAGEMENT**
